Enrichment Week Activity – Escape the Taskmaster

I am delighted to confirm details of your son/daughter's enrichment week activities. There will be approximately 46 students taking part in the activities and 6 members of staff. Details of the activity are as follows:

Due to the numbers of students involved we have to split them into 3 groups for Today's activity. **Groups A & B** will be back during school time. **Group C** will be back at school between 3.30pm and 4pm.
- **Wednesday 17th July 8.30 – 2.40pm:** Register in S41- students will complete a series of Taskmaster style challenges individually and as part of a small team.
- **Thursday 18th July 8.30 – 2.40pm:** Register in S41- students will complete a series of Taskmaster style challenges individually and as part of a small team.
- **Friday 19th July 8.30 – 2.40pm:** Register in S41 -students will complete a series of Taskmaster style challenges individually and as part of a small team.

Enrichment week for all students is **non-uniform**; however, sensible clothing must be worn. During the school day break time will be 10.30 – 10.50 and lunch will be 12.10 – 12.40, the canteen will be open as normal for students to purchase refreshments.
